**ARKANSAS CONTRACTORS LICENSING BOARD**

**vs.**

**ROSE ELECTRIC, INC.**

**ORDER**

The Board voted unanimously that Rose Electric, Inc. shall pay a civil penalty of \$457.00 for violation of Act 150 to the Board payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

**ORDER**

The Board voted unanimously that Lyndel Johnson, d/b/a Johnson Construction shall pay a civil penalty of the following: Church- There was a violation but assessed no penalty; City- \$400.00 for violation of Act 150; R & R- \$2,582.00 for violation of Act 150 for a total of \$2,982.00 to the Board payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

The Board voted unanimously that Lonnie Nickols, d/b/a Nicko Builders shall pay a civil penalty of \$2,468.00 for violation of Act 150; \$4,113.00 for violation of Act 162 as amended for a total of \$6,581.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

The Board voted unanimously that Willie Warren, d/b/a Willie Warren Construction shall pay a civil penalty of \$980.00 for violation of Act 150; \$980.00 for violation of Act 162 as amended for a total of \$1,960.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

The Board voted unanimously that Jimmy's Plumbing, LLC shall pay a civil penalty of \$400.00 for violation of Act 150; \$400.00 for violation of Act 162 as amended for a total of \$800.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

**ORDER**

The Board voted unanimously that Ronnie Barbee, d/b/a R & B Construction shall pay a civil penalty of \$984.00 for violation of Act 150; \$984.00 for violation of Act 162 on the Church project; \$1,209.00 for violation of Act 150; \$1,209.00 for violation of Act 162 on the R & R project for a total of \$4,386.00 on both projects. This amount is reduced to \$1,462.00 if there are no further violations for 2 years. The penalty is payable within twenty (20) days of receipt of this Order and Ronnie Barbee, d/b/a R & B Construction shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

Johnson Roofing & Remodeling, Inc. shall pay a civil penalty of \$1,053.00 for violation of Act 150; \$3,510.00 for violation of Act 162 as amended for a total of \$4,563.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

**COCHRAN-HIGGS CONSTRUCTION, INC.**

**ORDER**

The Board voted 5 to 1 that Cochran-Higgs Construction, Inc. shall pay a civil penalty of \$1,086.00 for aiding and abetting an unlicensed contractor to the Board payable within twenty (20) days of receipt of this Order. Further, the

Board shall hold the renewal application of Cochran-Higgs Construction ,Inc. for 6 months before considering the renewal. Cochran-Higgs Construction, Inc. shall refrain from aiding or abetting or using contractors in violation of the contractors licensing law.
